### Notification

In continuation of this office letter no. Registration / 1105 dated 13.07.2018, the following procedure will be followed for submission of online University Registration fee for the students admitted in the current session 2018-19: -

- a. The Students of P. G. Regular Courses (Programme) i.e. M.A., M.Sc., M.Com, M.Ed., LL.M, IPA, P.G. Self Financing Courses (Programme) / P.G. Diplomas and Ph.D. programme will submit their original migration certificate alongwith the admission receipt in the respective Departments / Institutes and respective Departments / Institutes after updating the data regarding Migration No., date of issue of migration and the Name of the Board / University will forward the data and the forms to the Deputy Registrar / Registration Section, Patna University. The Registration Section after verification and further updation of the data regarding Registration fee and the Registration number will forward the same to the agency concerned. The students may download the University Registration receipt after payment of the requisite fee.
- b. The Students of all Colleges will submit their original migration certificate alongwith the admission receipt in the respective College and the respective College, after verification and further updation of the data will forward the same to the agency concerned. The students may download the University Registration receipt after payment of the requisite fee.

- c. The Form charges of Rs.30/- only will be added in the University Registration fee. The Registration fee of the students who passed through the Bihar School Examination Board is Rs100/- only and for other boards / University is Rs.200/- only.
- d. The University registration fee will be acceptable till 31<sup>st</sup> October 2018 without fine and thereafter Rs.1000/- will be charged as late fine.


